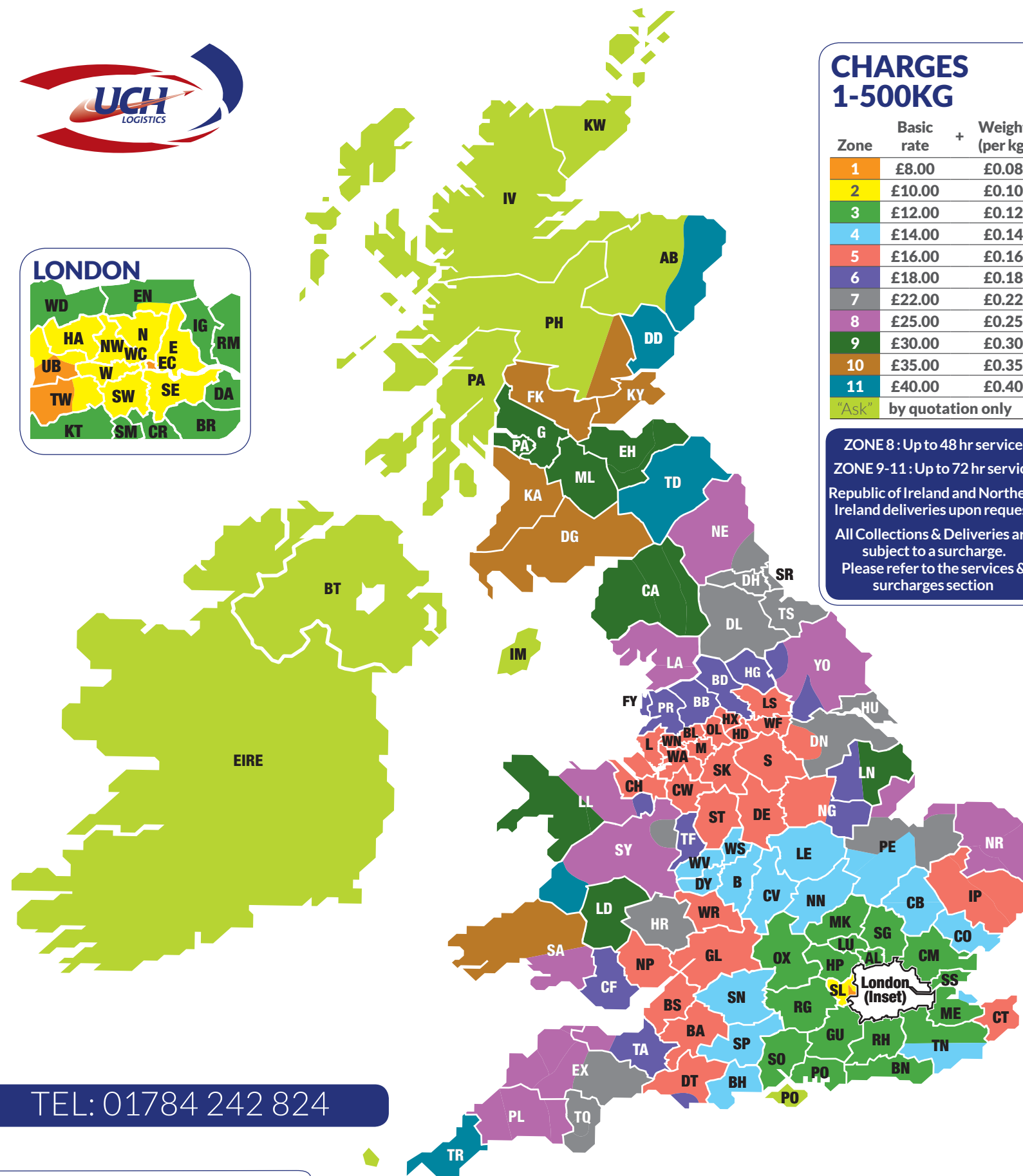
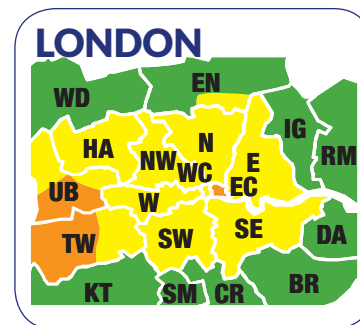

GENERAL INFORMATION

- All zonal collection & delivery services are based on a five day working week (Mon-Fri), excluding Bank and Public holidays. Consignments on weekends and holidays can be arranged with our operations staff, subject to special rates.
- All consignments are subject to a standard volume charge of 6m³ = 1000kgs.
- Any Hazardous freight collected loose must be over-packed and labelled as such, alternatively the freight must be palletised and shrink-wrapped to pallet(s) for travel. If cargo is not appropriately packaged UCH will not accept liability for damage.
- Collections from one area for onward delivery to another will be charged as separate jobs (one for collection, one for delivery), unless prior arrangement is made for a special delivery (where possible due to location).
- False calls are charged in full, according to the booked weight or volume (whichever is greater).
- Waiting times will be charged as per our tariff.
- Scottish bound shipments must be at UCH by 6pm in order to connect with the Scottish trunker. To guarantee connection on the day of booking, a special airline retrieval booking will be required. Price on request.
- Saturday import collections and Export deliveries are arranged as specials only.
- Delivery into an Airline will be subject to our Export tariff.
- All Export cargo delivered into an airline will be made known by UCH unless explicitly requested otherwise.
- All cargo is assumed to be stackable unless specifically stated otherwise. Any cargo that is non-stackable requires quotation prior to booking.
- All loose cargo collected from handling sheds are subject to pallet exchange. Pallets used to deliver loose cargo to a destination where pallet exchange is unavailable will attract a £7.00 fee per pallet. If pallets are available for exchange, no fee is applicable.
- All access and site restrictions that hold bearing on vehicle type and/or equipment requirements must be advised at the point of booking and stated on transport notes to avoid service failure.
- Export documents must be securely attached to any cargo being collected by UCH and must not be handed to a driver – UCH cannot be held responsible for mislaid documents if they are not attached securely to the cargo.
- Any Imports where the volume or gross weight is under declared by more than 30% will be subject to a 50% uplift on the original booking fee.
- The charge for spreaders will be £10.00 per spreader

SERVICE DETAILS

NEXT DAY – Normal working day delivery or collection between 9am & 5pm.

AM – Delivery or collection at any non-specific time between 9am & 1pm.

PM – Delivery or collection at any non-specific time between 1pm & 5pm.

TIMED – Delivery or collection within a 1 hour window of the requested time between 9am and 3pm on working days .

C.O.D. – Cheque or cash on delivery. Cheques must not be made payable to UCH.

HAZ – Any job that is considered Hazardous under the Carriage of Dangerous Goods by Road Regulations and requires a HAZ aware driver, will be subject to a hazardous surcharge.

WAITING TIME – to ensure UCH can continue to provide cost competitive rates we cannot be delayed by the customer when loading / unloading freight. UCH allow 15 minutes after which there is a waiting time surcharge.

FREIGHT SIZES

We will cover freight up to 2 metres long, 1.2 metres wide and 1.7 metres high. Any freight in excess of these dimensions is considered “out of gauge” and can be handled subject to quotation & specific arrangement. In addition, any consignment needing a curtain sider, tail-lift or any other special consideration will be subject to prior arrangement and quotation.

FALSE CALLS

Our vehicle timetables are organised by location and the greater of either weight or volume, and are subject to strict deadlines for both deliveries and collections.

If we have scheduled a collection to a vehicle and the freight is not available or cancelled, this can cause a reduction in revenue that is difficult to replace. This can cause major delay that could jeopardise further consignment deadlines. Therefore, in most cases we need to make a charge equal to the booked weight / volume and relevant loss of revenue.

If the delivery is refused, particularly with heavy or bulky freight, then the freight has to be kept on the vehicle, limiting load space and vehicle availability. In such instances, we must not only charge for the aborted job, but also for any reduced availability of space or time which translates to a 50% uplift of the booking fee for the return.
