Dear Valued Customer

Please be advised of the below regards our ETSF service over the Christmas and New Year's schedule 2019.

The below charges will be applicable for shipments removed to our ETSF / ERTS Facility over the Christmas Period.

NOTE:- The free storage period will be reduced to 48 hours from midnight of the day the Status 1 is checked in our shed. The storage charges thereafter will be as follows

GBP10/100kg/day – For both Cleared and Un-cleared Freight.

Working hours and Cut-off times for Import clearances and ETSF removals will be as follows:

19 th DEC -Thursday : - MID-DAY	20 TH DEC FRIDAY : - MID-DAY
21 TH DEC SATURDAY: - 1000 hrs	22 TH DEC SUNDAY- MID-DAY
23 RD DEC MONDAY : - MID-DAY	24 TH DEC TUESDAY :- MID-DAY
25 TH DEC WEDNESDAY :- CLOSED	26 TH DEC THURSDAY : - 1000 hrs
27 TH DEC FRIDAY :- 1500 HRS	28 TH DEC SATURDAY :- 1000 HRS
29 TH DEC SUNDAY : - MID-DAY	30 TH DEC MONDAY : - 1500hrs
31 ST DEC TUESDAY :- MID-DAY	1 ST JAN WEDNESDAY : - 1000 hrs
2 ND JAN THURSDAY : - 1500hrs	3 rd Jan – Friday :- Normal service Resumes

In addition to the above, due to for ETSF over the festive period means we need to advise the following:

1. No BI's to be sent to UKX unless pre-approved by our ETSF team from Thursday 19th December until 2nd January 2020.

Should a BI be sent without prior approval from our ETSF team, UCH will not be liable for collection or any other fees relating to the shipment should it not be collected from airline.

2. Any airline collections in the above time frame will be charged as a Special.
3. Storage in ETSF will be reduced from 72hrs free to 48hrs from status 1 with both cleared and un-cleared charged at a rate of £10 / 100kgs per day.
4. Should you wish we can transfer cleared freight to UCH4, however this will be by written request only and subject to a bond transfer fee as well as relevant storage charges at UCH4.
